1. Program Background And Goals

In the United States, most innovation is created by venture businesses. Similarly in Japan, the leading companies that move industry forward start out as venture enterprises. Thus, in order to maintain and expand its competitiveness as a global city, Tokyo must foster the growth of a large number of venture businesses that can compete on the global stage.

In light of the above, we have launched a program to support the global expansion of venture businesses and other startups in Tokyo. This program offers overseas expansion support, including business matching with foreign corporations and venture capitalists, pre-matching training to refine company pitches, and other similar services. Through the program, venture businesses in Tokyo are provided with an opportunity to form partnerships that they will need when expanding overseas.

2. Eligibility

The purpose of this program is to provide Tokyo venture businesses etc. with overseas expansion opportunities; therefore, we welcome applications from individuals or companies that satisfy all of the following requirements.

- (1) Applicants must be a Tokyo venture business (i.e. a company that works with cutting-edge technologies, business models etc., and has an office in Tokyo; sole proprietors are welcome to apply as well).
- (2) Corporations may only apply if they have been founded less than ten years prior to April 1, 2017.
- (3) As a rule, applicants must have services/products for overseas expansion.
- (4) Applicants must be seriously considering business expansion in the region covered by the course. Additionally, program attendees must be an executive officer at their Tokyo venture business or have a position of authority that allows them to make decisions regarding overseas expansion.
- (5) Some aspects of the program will be conducted partially or entirely in English. Attendees of such programs must have a working knowledge of English.
- 5) Applicants must be able to attend all kickoff events, scheduled programs, and outcome announcements.
 - * Going forward, we plan on creating courses and offering programs related to other countries and regions. Please be advised that, in the event of a large number of applications, new applicants may be given priority over previous course attendees.
